house STAR application, to the web, where they could be run by users who send some of these reports to the Federal Drug Administration. Majority of the task at-hand, involved scheduling, emailing and exporting the reports into various formats using Crystal Enterprise 10.0 The reports provided by STAR application were developed using Crystal Reports version 8.0 and were used by managers directly via the Crystal Reports Designer. Managers had many issues with accessing and validating these reports, as many of them were extremely slow. I was hired to study these reports and their shortcomings in-depth, so as to be able to fix all the present bugs and glitches and improve performance.

- Proposed and oversaw the upgrade to Crystal Reports, version 10.
- Proposed the use and distribution of 15 Crystal Enterprise named user licenses, within the network.
