- Application server administration includes restart of server services on a regular basis; monitoring application server log files and user job history; monitoring online transactions and performance tuning.
- User security administration includes design and implementation of security hierarchy such as adding network user accounts and implementation of security classes; design user security access; setup access of user form, HR security, data security, drill around security, and printers.
- Web server administration includes setup and configuration of IOS services; setup and implement Portal; administer Portal user accounts, bookmarks, and user access and groups.
- Data management includes the creation of data areas and product lines; design and implementation of data backup; annual data purge; maintain relational databases used by the Lawson system; and refresh of data from production to test product lines.
- Data interfacing from various 3rd party systems such as a Time and Expense system to the Lawson system. Designed and implemented a custom interface system to import time/expenses and accounts receivables from external systems into Lawson. Designed and implemented custom programs that allows for the extract of Lawson HR information to various vendors such as healthcare providers. Previous client work has also included interfacing Kronos time records into Lawson.
- On-going production support of bi-weekly payroll for external clients. On call support for any payroll that may arise.
- Upgraded BSI Tax Factory from 6.0 to 7.0.e on both Unix and Windows platforms.
- Development work is mainly in the form of Lawson CASE and Tools to create custom modifications to the standard Lawson business logic. Created both online and batch forms along with user exits. Modified forms with Design Studio which allows for the standard Lawson code to remain unmodified.
- Setup and implementation of Employee Self-Service; Performed HTML customizations to display the literature required by HR; troubleshoot daily ESS user issues.
