This project was to bring the client back into compliance with their Lawson system for the Lawson Software support contract. This required a cyclical upgrade from 7.2.2 to 7.2.5 and upgrade to 8.0.3. Outlined the Lawson, AIX and Informix version requirements for the upgrade and acquired the upgrade materials. Created a detailed Lawson project plan and worked with the internal resources to upgrade the AIX and Informix versions. Documented all of the client's product modifications and worked with the business team to identify which were still required. Migrated Liberty Mutual Database and Custom Coding changes into the new Lawson version. Created new modifications and screens as required by the business through client testing. Created customized AR customer comment screens and database tables for Sarbanes Oxley requirements for the Insurance industry. The role expanded during this project to include production support and the recreation of code for a non-Lawson system.
